PRODUCT DESCRIPTION

XPERT Solvent Cleaner is a heavy-duty cleaner for concrete and masonry surfaces. It is specially formulated to dissolve grease, oil, tar, tire marks and solvent based curing compounds.

USES

- Horizontal or vertical, exterior or wellventilated interior concrete and masonry surfaces.
- Removal of hydrocarbon-based contaminants on sealed or unsealed surfaces.
- Garages, driveways, vehicular repair facilities, machine shops, manufacturing plants, loading dock areas.
- Removal of aged, solvent based curing compounds and sealers.
- Cleans floors and walls of printing inks, packaging. glues and solvent based tile or carpet adhesives.

ADVANTAGES

- Quickly removes built up deposits of oil, grease, tar and tile adhesives
- Economical alternative to mechanical removal methods.
- Softens and lifts old curing and sealing compounds for removal prior to recoating
- Penetrates and loosens hydrocarbon contaminants for economical cleaning and removal

PACKAGING

XPERT Solvent Cleaner is packaged in 5 U.S. gallon/18.7 Litre pails, shipped 36 per pallet shrink wrapped. Citrus Cleaner Degreaser or Heavy-Duty Cleaner / Degreaser must be used to clean surfaces following treatment with Solvent.

DIRECTIONS

Surface Preparation: Vacuum or sweep to remove any loose dirt, dust or debris. Use with adequate ventilation.

Unsealed Surfaces: Do not dilute XPERT Solvent Cleaner with either water or solvents. Apply XPERT Solvent Cleaner with mop or sprinkling can and allow to dwell for 5 minutes to loosen contaminants. Scrub with stiff bristle or wire brush or broom. Do not allow XPERT Solvent Cleaner to dry on floor. Add more material if required.

Dilute either Citrus Cleaner Degreaser or Heavy-Duty Cleaner / Degreaser by volume 8:1 with clean water. Rinse twice with copious amounts of clean, potable water.

Sealed Surfaces: Use caution if using XPERT Solvent Cleaner as a cleaner only, undiluted material will soften most sealers and curing compounds. Dilute 1:1 with water and scrub and rinse as stated above. If removal of sealing membrane is desired, apply XPERT Solvent Cleaner full strength and allow to dwell for full 5 minutes. Scrub area with Citrus Cleaner Degreaser or Heavy-Duty Cleaner / Degreaser as

directed above and rinse well two to three times.

CLEANUP

Rinse tools and equipment with xylene, xylol or mineral spirits.

LIMITATIONS

- Care must be taken when using XPERT Solvent cleaner on sealed or coated surfaces.
- Do not use on resilient tile or substrates other than concrete or masonry without applying a small test area. Product may soften or discolour other types of materials.

STORAGE

Store pails in cool, dry area away from sunlight and sources of heat. Shelf life is one year from date of manufacture.

CAUTION

Combustible liquid. Keep out of reach of children. Severe eye and skin irritant. Avoid contact with skin or eyes. Use with adequate ventilation, do not breathe vapours.
