PRODUCT DESCRIPTION

XPERT Fairing Coat is a fine filled, fastsetting, cementitious mortar, specifically formulated for the repair of damaged concrete where only a thin layer is required. The specially selected cements and polymers contained in XPERT Fairing Coat produces a fast-setting mortar with exceptional adhesion to concrete and masonry materials with negligible shrinkage.

APPLICATION INSTRUCTIONS

Preparation: All contacted surfaces must be free of oil, grease or other contamination which may inhibit bond. Any cracked or weakened concrete should be removed prior to being repaired to provide a solid foundation. Scabbling or water blasting should be used to remove laitance and provide a mechanical key.

Priming: Priming with XPERT SBR is essential to ensure good adhesion to the substrate. Where the substrate is very porous pre-dampening with water may be required. Free water on the surface will reduce the bond and ultimate strength.

Mixing: XPERT Fairing Coat is suitable for mixing using a drill and suitable paddle or by hand where only a small quantity is required. Use 3.0 – 4.5 litres of water per bag of XPERT Fairing Coat to achieve a

smooth, soft mortar consistency. Excess water will reduce the final strength and make application of the render more difficult. Always add the powder to the water while mixing slowly to avoid lumps. Only mix that quantity of material that can be used within the setting time. Do not attempt to rework or retemper any partially set product.

Application: Apply the mixed XPERT Fairing Coat to the substrate using a trowel to give the required finished thickness. The maximum thickness applied in any application should be limited to 5mm. Feather edging may be used in patch repairs.

CURING

The application of a thin coat of XPERT Cure W2 a curing membrane will reduce premature drying in repairs subject to direct sun or strong winds.

CLEAN UP

Clean all equipment with water immediately after use.

PACKAGING

XPERT Fairing Coat is supplied in 20 kg bags. XPERT SBR is supplied in 5- and 30-liter containers.

ESTIMATING DATA

A 20 kg bag of XPERT Fairing Coat will cover approximately 4 m² at an average thickness of 3mm. XPERT SBR is used at 5 to 7 m² per litre. A scabbled surface will reduce the area covered by the primer and topping.

STORAGE

XPERT Fairing Coat is a cement-based product which must store in a dry area off the ground.
